Commencing at a point in the line of formerly Ryan, said point bearing S. 50° 30' W. 30.10 feet from the centerline of the A & P Highway, thence parallel with and 30 feet from the said centerline N. 34° 45' W., 321.45 feet to an iron pin, said iron pin being the beginning point of this survey; thence the following courses and distances: S. 51° 28' W., 272.90 feet to an iron pin; thence N. 34° 45' W., 200.00 feet to an iron pin; thence N. 51° 28' E., 272.90 feet to an iron pin, said iron pin being 30.00 feet from the centerline of said highway; thence parallel with the centerline of said highway; thence parallel with the centerline of said highway S. 34° 45' E., 200.00 feet to the place of beginning and containing 1.25 acres of land, the same to be more or less. Situated in Ohio Township, Clermont County, Ohio and in the original survey of Robert Bealle, No., and more particularly described and founded as follows, to-wit:

Commencing at the point of intersection of the centerline of Little Indian Creek Rd.; produced with the southerly side of the concrete pavement of the A & P Highway, U.S. Route No. 52; thence with the southerly side of said concrete pavement the following seven courses and distances, S. 61° 2' E., 16.60 feet; thence S. 58° 25' E., 100 feet; thence S. 53° 32' E., 100 feet; thence S. 48° 21' E. 100 feet; thence S. 34° 43' E., 294 feet to the point in the southerly side of said concrete pavement; thence leaving the concrete pavement, S. 51° 28' W., 20 feet to an iron pin, corner to Patrick Regan and Cora Pohl, said iron pin being 30 feet distant from the centerline of said highway; thence with the line of said Regan, paralleling and 30 feet distant from the centerline of said highway, S. 34° 45' E., 200 feet to an iron pin, the
